5. There are no refunds or credits issued for any reason. Including, but not limited to unfavorable weather conditions, vendor absence, mechanical breakdown, etc.
6. Vendor must be on-site by 9:00AM. Failure to do so will forfeit any rent paid.
7. **Setup starts at 9am. No merchandise or displays are to be unloaded on the street before 9am.**
8. Producer may cancel the festival if:
  - The festival is unable to obtain NYC Mayor's Office and Community Board Approval
  - There is extreme precipitation (to be determined by 10am day of fair)
  - There is an act or threat of terrorism
