8. Vendor must be on-site by 9:00AM. Failure to do so will forfeit any rent paid.
9. **Setup starts at 8:30am. No merchandise or displays are to be unloaded on the street before 8:30am.**
10. Producer may cancel the festival if:
  - The festival is unable to obtain NYC Mayor's Office and Community Board Approval
  - There is extreme weather (to be determined by 10am day of fair)
  - There is an act or threat of terrorism
